David Williams, II - Rudolph C. Hasl Leader in Sports

Vice Chancellor for University Affairs & Athletics Director of Athletics and Professor of Law Chair of NCAA Infractions Appeals Committee Member of NCAA Academic Cabinet Member of NCAA Enforcement Working Group

David Williams is currently serving as the Vice Chancellor for University Affairs & Athletics, Athletics Director and Professor of Law at Vanderbilt, Chair of NCAA Infractions Appeals Committee, a member of NCAA Academic Cabinet and a member of NCAA Enforcement Working Group. Mr. Williams is a tenured full professor at the Vanderbilt School of Law, where he teaches Tax Law, Sports Law, and Law and Education. In addition, he teaches a course on Law and Higher Education at Vanderbilt's Peabody College.

Mr. Williams serves as one of the Vice Chancellors at Vanderbilt University where he oversees Student Affairs, the Recreation Center and Student Athletics.

Mr. Williams is a member of the State Bars of Tennessee, and Michigan, as well as the District of Columbia Bar. He is an active member of the American Corporate Counsel Association (ACCA) and the American Bar Association (ABA). He is a member of the National Association of College and University Attorneys (NACUA) Board. Mr. Williams is a member of the ABA's Bar Admissions Committee and has served as a member of the ABA Section of Legal Education and Admissions Standards Review Committee and the ABA's Standing Committee on Public Education.

As a member of ABA's Section of Business Law, Mr. Williams has served as Co-Chair of the Corporate Counsel Committee. He also has served on a number of ABA Accreditation site visits of Law Schools and has completed a three-year term for the Membership Review Committee of the American Association of Law Schools (AALS). Mr. Williams is currently serving his second three-year term as a member of the Nashville Branch of the Atlanta Federal Reserve Board, and his second one-year term as Chair. Mr. Williams is serving as a member of the NCAA Infractions Appeals Committee and the NCAA General Counsel Advisory Board.

Mr. Williams is active in the Nashville community, serving as Treasurer and member of the Nashville Symphony Board of Directors as well as Chair of its Finance Committee. He serves as Treasurer and member of the Nashville Public Television Board and is Chair of its Finance Committee. In addition to serving as a board member for many other non-profit organizations in the community, Mr. Williams recently served as a member and Chair of the School Funding Task Force for Metropolitan Nashville Public Schools, and currently serves on the Mayor's Procurement Standards Board. Mr. Williams has written, lectured and participated in many seminars on topics of tax law, sports law, law and education and legal history. He has taught at the Law Schools of the University of Detroit, Capital University, The Ohio State University and Vanderbilt University. He directed The Ohio State University Law Program in Oxford, England in 1992 and 1995.

A native of Detroit, Michigan, Mr. Williams received a Bachelor of Science (Social Science) and Master of Arts (Education) from Northern Michigan University; a Master of Business Administration and a Doctor of Jurisprudence from the University of Detroit; and an LL.M. (Taxation) from New York University.

Rodney K. Smith Professor of Law Director, Center for Sports Law & Policy at Thomas Jefferson School of Law Board Member, National Sports Law Negotiation Competition

Rodney K. Smith received his B.A. from Western Colorado State College, his J.D. with honors from Brigham Young University, and his LL.M and SJD from the University of Pennsylvania, and holds honorary doctorates from Capital University and Southern Virginia University. He currently serves as a Distinguished Professor of Law and Director of the Center for Sports Law and Policy at the Thomas Jefferson School of Law.

He previously served as President of Southern Virginia University and as Chairman of the Board of Trustees of the American Academy for Liberal Education. Professor Smith has served on the International Board of the J. Reuben Clark Law Society, and recently served as a Visiting Professor at the Washington and Lee College of Law teaching Sports Law in their nationally recognized practicum. Professor Smith previously served as dean of the schools of law at Capital University, the University of Montana, and the University of Arkansas at Little Rock. He also taught at the University of North Dakota, Widener University, Brigham Young University, and the University of San Diego. Professor Smith held the Herff Chair of Excellence in Law and served as interim dean at the University of Memphis immediately prior to his service as President at Southern Virginia University.

Professor Smith is also the author of more than twenty-five scholarly articles and is recognized for his scholarship in the freedom of religion and sports law areas. He writes regularly for the opinion sections many newspapers, including USA Today, The Christian Science Monitor, Washington Times, Houston Chronicle, Commercial Appeal (Memphis), Union Tribune (San Diego), Deseret News (Salt Lake City), etc., and regularly appears as a commentator on radio and television programs.

Professor Delman has a varied background in civil litigation with an emphasis in medical malpractice. While at law school, she was editor of the American Criminal Law Review. After graduation she was selected for a judicial clerkship in Pennsylvania. Upon completing her clerkship, she worked in a large Philadelphia firm, where she specialized in medical malpractice litigation. Moving to San Diego, she joined the litigation department of the city's largest law firm. Professor Delman also served as counsel to a medical products corporation.

Since she joined the faculty, she has served as faculty advisor to the Law Review, Society of Law and Medicine, student chapter of the American Civil Liberties Union, and Law Students for Reproductive Justice.
