AWARD ELIGIBILITY REQUIREMENTS:

- Applicant must have completed **at least** one year of law school, must have demonstrated legal aptitude, and must be in good standing at a school of law in California that is accredited by the State Bar of California.
- Applicant must be a resident of Fresno County. (A law student attending a State Bar of California-accredited law school in California located outside Fresno County *is* eligible to apply if his or her permanent family residence address is located in Fresno County, California.)
- Applicant must complete the FCBA Spring 2019 Scholarship Award Application form and mail the completed form to:
